## APPLICATION GUIDE

Apply through boom spray, aerial, fertigation, or overhead irrigation. DO NOT apply when conditions are extremely hot. Best applied in temperatures in the range of 5 - 25 degrees Celsius. Preferably early in the morning or late in the afternoon.

## MIXING INSTRUCTIONS

1. Shake bottle before application.
2. Half fill tank with required volume of water.
3. Add the required amount of BioHub B4TF.
4. Fill the remainder of tank with water and maintain agitation.
5. Start application within 1 hour of final mixing.
